Hope this finds you doing well. It's been a year since Ponderosa MHP was bought by the City of Boulder. We've come a long ways in that time, and it's been a dynamic transition. It will continue to be more dynamic for several years before things settle down. So thank you for you participation, patience, and openness to new ways as we continue on.

There is a constant debate about whether folks should stay in their existing mobile home or get a new Habitat for Humanity home. You probably didn't ask my opinion but enough people have asked me that I'll give my opinion to everyone. It seems very simple. If you want a great financial deal and improved safety, get a new Habitat home. Keep your existing mobile home for nostalgic and sentimental reasons or you just can't stand the hassle of moving into a new place.

A few other things:

- The website that Trestle did is awesome! **ponderosaboulder.weebly.com**
- We always encourage residents to try and work out issues between themselves before getting management involved, but we are there to help when that doesn't work.
- Colorado Security Services is now patrolling our property to help us with any problems.
- We are MUCH better at recycling and are 90%+ of the way to being right where we need to be. If you still need a quick refresher, there is a great 3 minute video at
 https://bouldercolorado.gov/zero-waste/what-goes-where. It's always easier to watch a video as opposed to reading a manual.
- Composting will start mid to late October.
- We are still doing the cat trap/spay/neuter program.

City Council Meeting Update

Danica stated that the next City Council Meeting will be at 6 PM on Thursday, August 23rd. All residents are encouraged to attend the meeting to give a 3 minute statement regarding concerns about Ponderosa.

Rules and Regulations Feedback and Security

Leslie Pinkham lead a spirited discussion about pets, specifically dogs and cats. One change in the Rules and Regulations is that each household can have five (5) fur-bearing pets. With regards to safety in Ponderosa, a private security company has been hired by the City of Boulder to provide security for the Ponderosa residents.

Communications Update - Community Connectors

The role of a Community Connector was discussed, and it was agreed that this would be an opportunity for residents to become more involved in Ponderosa. Community Connectors would be a specific group of residents who would volunteer their time to inform other residents of Ponderosa changes. Danice announced that all of the forms of communication (text, email, Ponderosa website) are working well so that all of the residents are informed.

Citizen's Police Academy

Marina briefed the RLC that there is a training on August 11th for anyone who is interested. Please contact Marina or the Boulder Police Department for more information.

NoBo Library Community Engagement

Celine and Lilian announced that a new library will be built in North Boulder (site yet to be determined). 


City Council Public Hearing for Ponderosa Concept Plan on August 23 at 6:00 PM

On June 18th, Boulder City Council "called up" the Ponderosa Concept Plan in order to hear from the residents and provide additional input. The hearing will be on August 23. The meeting will take place at 6 PM at Council Chambers (1777 Broadway, second floor) and Ponderosa should be the FIRST item on the agenda. City Council members are interested in hearing from Ponderosa residents - please come to the meeting to share your thoughts and perspectives on the annexation. As always, Spanish interpretation will be provided. The Trestle team will play the resident video that was shown at Planning Board on June 7th.

- Are considering a new Habitat home and want to start the process of understanding your option.
- Just want to meet us or learn more from us and from your neighbors.
- Want to learn about other opportunities.

At this upcoming session, in addition to Greg Gustin, (property manager), Leah Gutierrez (Habitat for Humanity homebuyer program), Crystal Launder (project manager for the Ponderosa Community Stabilization Project), and Marina LeGrave (cultural liaison and interpretation), we will be joined by:

- Leslie Pinkham, city staff overseeing property management, who will be available to answer questions or hear concerns about the <u>new Rules and Regulations</u> and <u>security concerns in Ponderosa</u>.
- Nino Gallo, Boulder County PIE (Personal Investment Enterprise) program, who can answer questions about this 1:1 match program and get Ponderosa resident started. For every dollar a participants deposits in their savings, Personal Investment Enterprise will deposit matching funds on a 4:1 ratio up to \$4,000.00 for education, small business, or a down payment on a home.

UPDATE FROM HABITAT FOR HUMANITY



Flatirons Habitat for Humanity is seeking future homeowners for our Palo Park and King's Ridge developments.

You may be eligible for our homeownership program if you . . .

- 1) ...have lived or worked in Boulder Valley School District or the City and County of Broomfield for 12 of the past 24 months
- 2) ...are paying more than 30 percent of your total household income on rent
- 3) ...are willing to partner with Flatirons Habitat for Humanity, including contributing 225 hours of sweat equity to build your home
- 4) ... have the ability to support a mortgage and have had a steady income for at least 2 years
- 5) ...fall within 60%-80% Area Median Income (AMI) guidelines (see AMI chart at www.flatironshabitat.org)

If you are interested in our homeownership program, you <u>must</u> attend an orientation session.
